

## Cookie Statement of magnett.

This Cookie Statement explains how Goozy s.r.o. (“Goozy,” “we,” “us,” or “our”) uses cookies and similar technologies to recognize you when you visit our website [www.magnett.io](http://www.magnett.io) or other websites managed by Goozy where this Statement is posted (“Website”). It explains what these technologies are, why we use them, and your rights regarding the control of our use of these technologies.

For more information about how we process other categories of personal data, please refer to our Privacy Policy.

### 1. What Are Cookies?

Cookies are small files containing a string of characters that are sent to your computer when you visit the Website. When you return to the Website, cookies allow the site to recognize your browser. Cookies can store user preferences, remember login details, and other information.

### 2. Who Sets Cookies When Visiting the Website?

There are two main types of cookies:

- **First-Party Cookies** are cookies set by the website owner (in this case, Goozy).
- **Third-Party Cookies** are cookies set by parties other than the website owner. These cookies allow third parties to provide features or services on the website (e.g., advertising, interactive content, and analytics). The parties setting these cookies can recognize your computer both when you visit our Website and when you visit other websites.

### 3. What Types of Cookies Do We Use and How Do We Use Them?

We use both first-party and third-party cookies for several reasons. Some cookies are technically necessary to operate our Website and are referred to as "necessary" cookies. Other cookies allow us to track and target user interests, improve their experience on the Website, and provide personalized content, advertisements, and analytics.

Specific types of cookies we use include the following categories:

- **Necessary Cookies:** These cookies are essential to provide basic services and functions on the Website (e.g., authentication, fraud detection, security, and functional cookies).
- **Preference Cookies:** We use them to remember your preferences and recognize you when you return to the Website, to improve the Website’s performance, and to provide various features across pages.
- **Analytical Cookies:** We use these to understand how the Website is used or how effective our marketing campaigns are. These cookies track and count page views, unique visits, and other metrics for statistical purposes.
- **Advertising Cookies:** These cookies allow us to target advertisements based on your interests. They track your visits across websites, prevent repeated ad displays, and help ensure the correct display of ads.

### 4. How Can You Control Cookies?

You have the right to choose whether to accept or reject cookies. We process preference, analytical, and advertising cookies based on your consent (Article 6(1)(a) of the GDPR).

You cannot reject necessary cookies as they are essential for providing our services. However, you can block or delete all cookies by changing your browser settings (e.g., Google Chrome, Safari, Internet Explorer, Mozilla Firefox, Opera) or by changing your consent settings here on the Website.

**5. Other Tracking Technologies**

We may also use technologies called clear gifs (Web Beacons/Web Bugs) to help us manage the Website more effectively by informing us which content is effective. Clear gifs are tiny graphic files with a unique identifier, similar to cookies, and are used to track the online movements of users. Unlike cookies, which are stored on a user's hard drive, clear gifs are invisibly embedded on websites or in emails.

We use clear gifs or pixels in our HTML-based emails to know which emails were opened by recipients. This allows us to evaluate the effectiveness of certain communications and marketing campaigns. Much of this data is aggregated. If you want to disable this tracking, you can do so by disabling images in the email itself.

**6. How Often Will We Update This Cookie Statement?**

We may update this Cookie Statement from time to time to reflect, for example, changes to the cookies we use or for other operational, legal, or regulatory reasons. When we make changes, we will update the "Effective Date" at the top of this page. We encourage you to review this Cookie Statement regularly to stay informed about our use of cookies and related technologies.
