

Magnett Privacy Policy

At Goozy s.r.o. (“Goozy,” “we,” “our,” or “us”), the protection and security of personal data is a top priority. This Privacy Policy (“Policy”) outlines how we collect, use, share, and protect personal data of our service users, customers, website visitors, and other data subjects.

1. Scope and Purpose of this Policy

This Policy applies to personal data that we collect and process in connection with our services, the website www.magnett.io (“Website”), and other channels we manage. It describes how we process personal data of customers, users of our Website, potential customers, partners, their representatives, and other individuals (“data subjects”).

2. Personal Data We Collect

We collect and process the following categories of personal data:

- **Account Data:** Identification data such as name, email, phone number, address, login information, and data about connected accounts on social networks and other external services.
- **Financial Data:** Payment information such as payment card details (only the last four digits), payment history, and billing information.
- **Contact Data and Business Information:** Information collected to communicate with customers, potential customers, partners, and other individuals, including name, position, company, email, or other contact information.
- **Technical Data and Usage Data:** Automatically collected metadata and logs, which may include IP address, browser type, browser configuration, language settings, visited pages, and other technical data related to your interaction with our services.

3. How We Collect Personal Data

We collect personal data primarily in the following ways:

- **Direct Data Submission:** We collect personal data you provide directly through forms on the Website, during Service registration, or via email and chat communication.
- **From Automatic Sources:** When you interact with our Website and Services, we automatically collect certain technical data and information through cookies and other tracking technologies. Details on cookie usage can be found in our Cookie Statement.
- **From Third Parties:** We may receive data from third parties, such as payment service providers, social networks, business partners, and other external entities.

4. Purpose of Processing Personal Data

We process your personal data for the following purposes:

- **Providing Our Services:** We process personal data to ensure the delivery of our Services, account management, billing, and the delivery of technical notices, updates, and security alerts.
- **Communication with Customers:** We use personal data to send information about our Services, promote our events, and provide marketing communications where permitted by law.
- **Legal Compliance:** We process personal data to comply with applicable laws, tax and accounting requirements, and in case of legal disputes and statutory requests from government authorities.

- **Security and Misuse Prevention:** We process personal data to protect the rights, safety, and property of our company, customers, and other individuals.

5. **How We Share Personal Data**

We do not share your personal data with third parties for their commercial or marketing purposes. Personal data is shared under the following conditions:

- **Service Providers:** We work with third parties that provide services such as payment processors, cloud service providers, and others. These third parties have access to personal data only for fulfilling their contractual obligations.
- **Professional Advisors:** We share data with our legal advisors, auditors, and other professionals to provide expert services.
- **Business Partners and Integrations:** In some cases, we share data with applications and platforms where our customers integrate their accounts, such as social networks.
- **Legal Obligations:** We may share personal data with law enforcement and other government authorities in accordance with applicable laws.

6. **Your Rights and Choices**

As a data subject, you have the following rights:

7. **How Long We Retain Personal Data**

We retain your personal data only for as long as necessary to fulfill the purposes for which it was collected or as required by applicable laws. Upon the expiration of the relevant retention period, your personal data will be securely deleted or anonymized.

8. **International Data Transfers**

Your personal data may be stored and processed in any country where we operate or engage service providers. We transfer personal data in compliance with applicable laws and with appropriate safeguards to protect your personal data.

9. **Information about Children**

Our Service is not intended for individuals under 18 years of age. We do not knowingly collect personal data from individuals under 18. If we become aware that we have inadvertently collected data from someone under 18, we will delete this data without undue delay.

10. **Security**

We take reasonable technical and organizational measures to protect personal data from unauthorized access, loss, misuse, or destruction. Despite all efforts, we cannot guarantee absolute data security, especially during transmission.

11. **Legal Bases for Processing Personal Data (for EEA Customers)**

We process personal data based on several legal grounds, including contract performance, legitimate interests, and compliance with legal obligations. Detailed information about legal bases can be found in the relevant section of our policy.

12. **Changes to Our Privacy Policy**

We reserve the right to update this Policy from time to time. If we make significant

changes, we will notify you in advance so that you can review the changes and raise objections if necessary.
